

Jonathan's Place is accepting applications for a full-time **Professional Foster Parents** for the RESET (Restoring and Educating Survivors to Empowerment and Transformation) Long Term Foster Care. This position provides care to minor victims of sex trafficking in your home. Professional Foster Parents are employees of Jonathan's Place and are paid a salary. This individual is responsible for daily care and supervision of survivors. This is a full-time, salaried exempt position that may also receive daily reimbursement, as applicable. This position will serve as the primary caregiver for one or two minor victims of sex trafficking. If a child is not in the home, the Professional Foster Parents will still maintain the home to standard and will be prepared to receive a young person when needed. This individual is being paid to be available, trained, and prepared to support other Professional Foster Parents and advocate for the population even when there is no child in the home. Due to this, the Professional Foster Parents must not work outside of the home.

RESET Professional Foster Parent is a full-time position. Jonathan's Place offers a comprehensive benefits package including health coverage, 401k, and other ancillary benefits. Submit cover letter, resume, and salary requirements to emosman@kidnet.org.

Responsibilities Include:

- Engages in a trauma informed model of programming to provide physical and emotional safety for residents.
- Supervises residents in various activities in order to observe and promote positive social behavior effect changes in their social behavior.
- Models and teaches life skills to clients that will help them develop interpersonal relationships and social skills.
- Observes methods/techniques of clinical staff and participates in treatment of residents through interaction, limit setting, and implementation of treatment plans; also responsible for co-facilitation and involvement in clinical groups.
- Administration of psychotropic medication and/or other prescribed medications.
- Monitor completion of daily hygiene routines/chores.
- Provide crisis intervention and conflict resolution as needed.
- Attend and transport client to all appointments
- Completion of required training

Spouse/Partner Requirements (if applicable): The spouse/partner of this employee has no employment status with Jonathan's Place. This person is required to meet certain criteria, including a passing criminal background check and child abuse registry check, satisfactory health exam, negative TB and drug test, attend required training, and other requirements to become a foster parent. Some of these must be completed prior to the employment of the spouse/partner. Details regarding all requirements applicable for the spouse/partner will be provided prior to the offer of employment.

Requirements:

- High School Diploma or equivalent.
- Minimum of one year of experience working with children who have experienced trauma.
- Prior experience working with survivors of commercial sexual exploitation is preferred.
- Knowledge of child development and behavior management.
- Must have at least one bedroom for each youth placed in the home. Children may not share a room with biological, adopted or child in custody of the Professional Foster Parent.
- No other child in the home may be over the age of 9. Special considerations may be made on a case by case basis, determined by Jonathan's Place.
